is already shaping up to be a very exciting year for Arts Access. Highlights include Arts Access' Cultural Exchange Program which will see two visual artists, Claire Humphrys-Hunt and Jennifer McCarthy travelling to China in May to undertake projects in Jilin and Jiangsu Provinces; the establishment of the Art and Health Program (we'll have more about this program in the next edition) and in October the launch of the Melbourne Venue Guide which will have comprehensive access information on more than 110 of Victoria's major venues. As you can see from the article on DADAA (Disability in the Arts, Disadvantage in the Arts Australia) on page 7, there have been some major developments within the Australia Council stemming from their Art and Disability Report which was published recently. It is interesting and satisfying to note that this research project was a direct outcome of the 1993 DADAA National Conference. Arts Access is currently the national convenor of DADAA. (Copies of the Australia Council report are freely available from Arts Access so do please ring if you would like us to send you one.)

Finally Vivian Carroll, who will be well known to many of you as the Public Affairs Manager, has left Arts Access. I want to thank Vivian for the very significant contribution he has made over the four years he has been with the organistion. We all wish Vivian the very best for the future.

Administration is the oil that keeps the organisation running smoothly but its role isn't always adequately acknowledged. So to set the record straight it's a great pleasure to start our profile section with two key members of the Arts Access team — Samantha Marsh and Rhona Bester.

Samantha is Arts Access Administration Officer and Director of First Impressions. It is usually Samantha's voice that you hear first when you ring Arts Access and more often than not it is she who answers your enquiries. Samantha brings to her role a high level of skill and experience. She joined Arts Access in early 1989 and is currently our longest serving staff member. Besides her front desk duties, Samantha is responsible for co-ordinating the studio, compiling the monthly Arts Update bulletin and for the administration of the training program.

Rhona is also an invaluable and long standing member of the Arts Access staff having joined the organisation in 1990. As Administrator, Rhona is responsible for many aspects of the day to day operations of the organisation. She has established and maintains key administration processes which enable a high level of control and monitoring of finances and administration. Rhona is also responsible for the Arts Access volunteer program and for the development and implementation of our computer strategy which in 1995 saw the establishment of a networked system.



Arts Access is commencing 1996 with a range of exciting initiatives and projects:

The Art Day Programs are conducted with people with intellectual disabilities in community centres in Spotswood and Dingley. These two programs operate on an annual basis with two key artists on each program, Lyndsay Mason and Claire Teisen at Spotswood and Gali Weiss and Charles Robinson at Dingley. Barbara Doherty, the co-ordinator of the Art Day Programs, has produced a promotional brochure which provides details about these programs and the brochure is now available through Arts Access.

The Juvenile Justice Program established in 1994, will be completed this year with projects at the Malmsbury Youth Training Centre and the Male Adolescent Program for Positive Sexuality (MAPPS) which is based in Parkville.

The MAPPS group will be working with visual artist Eamonn Scott, and plans are underway to conduct a creative writing project with trainees at Malmsbury YTC with Jenny Bright, a writer from Hepburn Springs.

The Supported Residential Services Program with house-bound residents in the western suburbs, will continue with a second stage this year and follows on from the pilot stage established in 1995.

The North Fitzroy Youth Refuge project with artist Maria Filippow will be completed in March and Maria has been conducting weekly workshops in a range of mediums including drawing, textiles, printing and wood carving.

The Heidelberg Hospital oral history project is now in the final editing stages. Linda Richter and Bronwen Beachey, through the RMIT Professional Writing and Editing Course, have prepared the material and stories of the World War Two veterans attending the Hospital's Work Rehabilitation Group. We are now working with Hospital staff on the design for this publication.

The Saturday Morning Art Classes are now running regularly throughout 1996 and are open to people with psychiatric disabilities who are interested in the visual arts. For further information and bookings please contact Sam at Arts Access.

The program for the proposed Art and Health Victorian Conference has been prepared by artists Maria Filippow and Sally Marsden. Arts Access is now developing submissions to funding bodies to conduct this conference in late 1996 or early 1997.





Arts Access Library and Information Service has now added the new technology of the Internet to assist with information collection and dissemination. Contact has already been made with new organisations interested in the arts and disability both locally and internationally. There are many exciting artistic and networking possibilities arising from access to this technology. Information on all aspects relating to arts and disability/disadvantage may also be accessed by phone, fax, mail and personal consultation.

Throughout 1996, the Information Service will be developing a series of Fact Sheets which will provide answers to the most frequently asked questions.



EASE Venue Access Program – The Guide so far...Venue Guide co-ordinator Lisa McKoy is currently collecting information on access and facilities at the 100 plus venues that will be included the Melbourne Venue Guide. Assisted by a number of volunteers and EASE staff, Lisa is conducting on-site visits to venues as diverse as The Last Laugh, The Melbourne Cricket Ground, Como House and The Werribee Open Range Zoo. This is the second phase in the project, following on from a two month research phase which included questionnaires and interviews with EASE subscribers, disability agencies and other consumers of the Venue Guide. Results of the research were used to establish the look, content and "feel" of the Guide.

The 1996 Melbourne Venue Guide will not only give up-to-date access information on Arts, Sporting, Entertainment and Cultural venues, but will be an invaluable cultural resource for the tourism industry, venue managers and the general public. EASE Industry Development Program Disability Seminars 1996

The Australia Council's Art and Disability Program In February this year the Australia Council held a one day meeting with the National Arts and Disability Network, DADAA (Disability in the Arts, Disadvantage in the Arts, Australia) at Council headquarters in Sydney.

Arts Access is both a member of DADAA and current national convenor of the network. The purpose of the meeting was for Council to consult with DADAA on the new Arts and Disability Action Plan which is being developed at the Australia Council. Both Jane Trengove and Helen Bowman attended the meeting from Melbourne.

The Action Plan is an outcome of recommendations made in the recently published Research Report on Arts and Disability tendered by the Australia Council in 1994. An Action Plan is a step-by-step way of addressing equity of access for people with disabilities in the receipt of goods and services and employment subject to the 1993 legislation the Disability Discrimination Act (DDA). In the case of the Australia Council the issues are those that affect people with disabilities who are consumers or practitioners of the arts.

This process offers two effective outcomes for people with disabilities involved in the art. First is the Australia Council's review of their internal policies and practices on access within the organisation. Second is that this will provide a leadership model for all Australia Council funded arts organisations around the country.

It is an exciting development, that the Australia Council as the peak national arts funding organisation is responding to the DDA so promptly and that the DADAA National Network is recognised by Council as the primary consultative body which will advise on the Action Plan.

Arts Access creates opportunities for all people to fully participate in the cultural and artistic life of the community. Arts Access is an independent, non-profit arts organisation supported by federal and state governments, business, philanthropic and private sponsors, membership and user contributions. Additionally, the Arts Access Trust is building an ongoing, independent source of income for future administration, research, and pilot projects.







Arts Access is supported by the Commonwealth Government through the Australia Council, its arts funding and advisory body; Arts Victoria, a division of the Department of Arts, Sport and Tourism; and Health and Community Services.

Arts Access manages three core programs -
