## CHAIRPERSON'S REPORT

Since 1989 Arts In Action has actively supported the contribution and recognition of people with a disability in the arts. There is a creative tension lying between the arts and disability sectors. Arts In Action lives in this creative space and enhances both sectors, enabling more meaningful engagements in the arts, pathways for leadership and increased opportunities for more people with a disability to participate in the arts.

2005 was a year of change. Art In Action renewed its focus on being the peak body for arts and disability in South Australia. This has involved strengthening our performance as an advocate, as a representative of a field of practice /artistic endeavour, and as the critical conduit between the arts industry and the disability sector. We have directed our energies to providing services such as information, education and facilitation, to artists with a disability, artists working with people with a disability, and communities with experience of disability.

Throughout 2005 the Board and staff of Arts In Action have been exploring a new, sustainable model for the High Beam Festival. Community consultation and negotiations with potential partners are still happening and the outcome of these will be announced later in 2006.

It's fair to say that 2005 was a year of consultation and consolidation. We have been working hard to get all the key elements in place to position Arts In Action as a leader in arts and disability advocacy and practice. We have developed a new staffing structure, led by the single, full-time leadership position of Executive Director. We have developed new job descriptions for the other staff positions so that their work supports the achievement of the objectives of our business plan. And we have secured triennial funding from Arts SA and the Australia Council on the basis of that business plan.

While our achievements over 2005 are due to the hard work and commitment of all of the staff and board of Arts In Action, I'd like to especially thank Kat Worth, who was chairperson up to October 2005. Kat shared her strength, compassion and commitment with us all and led the board through some very challenging times. I particularly like Kat's warmth, calmness and focus. I'd also like to recognise and thank Jayne Boase, our General Manager throughout 2005, for her contribution, perseverance and commitment to Arts In Action over the past six and a half years.

I'd like to recognise the contribution to each of the Board members too. For freely giving of their time, expertise and energy; for staying on task and making the hard decisions; for being leaders. Thank you also to all the artists, volunteers and community members who have been involved in Arts In Action over the past year. Special mention must be made of the ongoing support from the Governor Hindmarsh Hotel, where Club Cis held each month.

Heartfelt thanks to Sandy, Phil, Claire and Nikki.

I'd like to welcome our new staff, Executive Director, Peter Tregilgas and office coordinator, Emma Wilsher. As I leave Arts In Action, I'd also like to propose a challenge to the new Board, the staff and the community – to continue to bed down the planned changes to Arts In Action, including a name change and constitutional change. The thinking and planning behind our directions has been thorough and rigorous. The new directions reflect what our stakeholders want and what's needed in the years to come. Seize the increased advocacy role with energy and enthusiasm, as I believe opportunities will abound.

# EXECUTIVE DIRECTOR'S STATEMENT


In 2005 Arts in Action completed a planning and review process that began in August 2004. The process was extensive and included stakeholder consultations, external facilitation, staff and board planning.

The consultation has led to the development of a new strategic plan that reflects a focus on the maturing role of the organisation as the peak body for arts and disability in South Australia. This involves strengthening our performance as an advocate, as a representative of a field of practice/artistic endeavour, and as the critical conduit between the arts industry and the disability sector.

In 2006 (Arts in Action's 18th year) the board has committed itself to reform the constitution to confirm the role of peak body for arts and disability in South Australia. This restructure will also include renaming the organisation to reflect the priorities of access as voiced by our community. Further the highly successful High Beam program is being re-developed as a key tool of communication to service and promote the disability and arts sectors with a fresh and sustainable model.

Partnership is a key to success, celebrate where we have come from and now join with us to support the sector.

# TEAM REPORT

2005 was a watershed year for Arts in Action with a major emphasis on organisational review and restructure, refocussing and new directions for the organisation, culminating in a new five year business plan. This often challenging process was undertaken on top of the delivery of our usual services and programs, with some significant developments in this last area.

Our ongoing monthly music and dance event Club C continued throughout 2005, despite a funding shortfall for the year. Attendances were consistently pleasing and the range of performers and styles continued to broaden. Big thanks must go to Club C coordinator Claire Thackray for her ongoing commitment to the event and her tireless efforts in maintaining the only socially inclusive music and dance event in SA. We also thank The Governor Hindmarsh Hotel for its unswerving support for Club C for over ten years now and 2006 will see some significant new departures for our longest running program.

The Big Country Choir, our regional project with communities from the Clare and Barossa regions continued to flourish and strengthen as a unique expression of regional Australia. A major landmark for this integrated community choir was their appearance on the same bill as Teddy Tahu Rhodes at the 2005 Bundaleer Forest Weekend. The BCC also performed at numerous local community events throughout the year.

Our Pathways program, in partnership with Community Bridging Services, continued in 2005 with four workshops occurring throughout the metropolitan area every week, catering to up to eight participants each. A focussed program of workshops in visual arts practice for people with disabilities, Pathways has presented three professional exhibitions of participants' work so far, including the 2005 "Peace Plant" exhibition, hung at Pepper Street Arts Centre at Magill. Many of the works at this show sold; notably the Minister for Disability himself was amongst those purchasing works by Pathways artists at the exhibition opening.

An exciting new long term project, Reins, Rope & Red Tape was initiated in late 2005.

A mentoring program for young people with disabilities who identify as having a serious interest in pursuing work in the arts, RRRT aims to develop and nurture a new generation of cultural activists.

Nicci Parkin, Project Officer at AiA, must be acknowledged for her commitment to setting up this significant project. A Flinders University placement student, Maria Benazic (completing Honours in Disability Studies) laid very helpful groundwork for a disability cultural database in her time with us during 2005 and Nicci also undertook the supervision of Maria's placement at AiA.

AiA undertook some promotional support and coordinate a reception for the visiting China Disabled People's Performing Arts Troupe in October. This remarkable group of artists from all over China performed to a packed Her Majesty's Theatre and this was followed the morning after by a reception held at the Adelaide Festival Centre, hosted by AiA and very kindly supported by the Adelaide Festival Centre event staff.

Arts Access Australia, the national peak body for arts and disability and represented in SA by AiA undertook the production of a significant new resource focusing on arts and disability in Australia. Making the Journey is a book which outlines twelve case studies of arts and cultural organisations from around Australia who have implemented diverse strategies to enable access for people with disabilities. We can celebrate the fact that three of the twelve case studies in the book were from SA organisations. Making the Journey was launched by Greg Mackie, Arts SA Executive Director, at the Festival Centre Banquet Room. This event, produced by AiA and once again supported by the Festival Centre, was part of an extensive series of events in early December at the Centre celebrating International Day for People with Disabilities.





The organisation's review and its subsequent restructure process was a long and at times difficult process. However, the bigger picture outcomes will see AiA refocussing on its peak body role, with a stronger emphasis on advocacy and training. This will see the organisation in far stronger positions within both the arts and disability sectors. A new model for the High Beam Festival was also well-developed during 2005. The new approach will reduce the strain placed on the organisation by producing a biennial international festival and will be announced in 2006.

Our General Manager Jayne Boase saw her final year at AiA in 2005. In the role since 2000, Jayne's contribution to the organisation has been immense, steering AiA through two High Beam Festivals as well as immense change as the organisation has grown and developed. Indeed, Jayne's lasting contribution to AiA is to have managed its coming of age as a key cultural organisation in our state. Jayne's vivaciousness, intelligence, warmth, humanity and mischievous sense of humour will be missed by all those at AiA who worked with her.

AiA finished its year in temporary office space as the Halifax Street premises underwent a thorough refurbishment, including some structural maintenance. The results of this overhaul have provided AiA with professional and modem office accommodation, reflective of the organisation's fresh outlook. The temporary offices were provided by the landlord the Christadelphian Church. Our long term association with the Church has been a happy one and AiA thanks in particular Rob Hicks and the Church Committee for their ongoing support.

AiA relies on the support of many different people for its continued successes, including audiences, stakeholders and partners.

However there are certain individuals who deserve to be mentioned for their outstanding contribution: Kat Worth, Claire de Bruin, Clare Witham, Jodi Glass, the Arts in Action Board, Sandra Craig, Pat Rix, Rachel Fisher, Emma Webb, Daniel Daw, Gaelle Mellis, Cathy Nirta, Kate Jenkins, John Foubister, Chris Burford, Meghann Jones, Gavin Malone, Ronda Wallis, Sonia Donnellan, Pam Young, Quentin Kenihan, Brian and Viv Tonkin, Greg Milton, Tim and Chris Loft and our numerous volunteers.

AiA's work is developed through the ongoing generous support of The Australia Council for The Arts, The Government of SA through Arts SA, Health Promotions Through the Arts and the South Australian Office for Disability and Client Services. A newly invigorated and empowered agency, AiA looks to the future with confidence. Our fresh perspective opens up many new, exciting and dynamic possibilities and opportunities for people with disabilities in the cultural life of South Australia and we look forward to the year ahead.

#### NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The accounts have been prepared in accordance with applicable Accounting Standards issued by the Australian accounting bodies and the requirements of the Associations Incorporation Act (SA) 1985. The accounts have been prepared on the basis of historical costs and do not take into account changing money values, or, except where stated, current valuations of non-current assets. The accounting policies have been consistently applied, unless otherwise stated.

All projects, grants and activities are presented in detailed profit and loss statement format to more fully report on the financial activities of the association.

#### Income Tax

Arts In Action Inc is classed as a not-for-profit organisation and as such is exempt from income tax under sec 50-5 item 1.1 of the Income Tax Assessment Act 1997.

#### Segment Reporting

Arts In Action Inc is an organisation operating principally in South Australia and as such comprises only one reportable industry and geographical segment.

#### **Fixed Assets**

All fixed assets are recorded at their original cost and have been depreciated over their useful lives.

#### Project Funds Carried Forward (refer Note 2 attached)

The unspent balances of projects which commenced prior to balance date and are of an ongoing nature are shown as current liabilities in the balance sheet. Government grants for annual funding of activities, for projects of less than twelve months, and for operating activities have been fully accounted for in the annual accounting period with surpluses and deficits being transferred to Members' Funds or reserves.

#### **Employee Benefits**

Provision is made in respect of the association's liability for annual and long service leave on the basis of the terms of their employment.

Contributions are made by the association to an employee superannuation fund and are charged as expenses when incurred. The association has no legal obligation to provide benefits to employees on retirement.

#### Members Subscriptions

Members' subscriptions are accounted for on a cash basis, being brought to account when received.
