President's Letter

This report marks the end of the 7th year of Sprung!! workshops, the end of the two years of an NDIS-funded Senior Dance Program during which our annual income has risen to four times previous levels, and a year which has seen the development of what was to become our most financially successful project to date. The amazing, "parade of life" dance theatre cabaret, "French Café", premiered at the Brunswick Picture House in July 2019 just into our next year's report- so stay tuned- but was developed throughout this year!

Operationally we facilitated a staggering 165 days of workshops, and mounted 25 performances, in venues as diverse as the Lismore Quad and House with No Steps locally, to the Melbourne Crown Conference Centre and Brisbane Powerhouse nationally. These performances were made possible with the contributions of 28 paid artists including 7 paid performers with disability.

Other personal highlights of YE 2019 included:

- the first Sprung!! GOLD project, a pilot partnership with Feros Aged Care on French Café themes that culminated in a packed Gala celebration with performers ranging in age from 17 to 99
- our first research endeavour, the CASP and NRCF funded project with clowning
 pedgagog Giovanni Fusetti which sought to ask, "what techniques of clowning or
 bouffon are most effective in co-creating comedy with persons with intellectual
 impairment" (our head of clowning Kate McDowell is further exploring this topic in a
 Masters thesis with the National Institute of Dramatic Art)
- the rise of our first weekly "Open Doors" dance program in Lismore, where Tora Crockford and Katie Cooper-Wares are achieving minor miracles with their precise educational balance of discipline and freedom for 7 enthusiastic dancers with disability
- the increased agency which we are witnessing from the trainees in our senior dance program, whose characters were the backbone of French Café success and whose individual choreographic development will be witnessed next year in their long term collaboration with Michael Hennessy, "O, How I Dreamt of Things Impossible", which has been provisionally scheduled as part of the NORPA 2020 season.

The essential governance overhaul of the last financial year put us in a much stronger position to understand and manage risk and futures planning and operations as a medium sized arts organisation operating as an emerging player in the national arts and disability scene.

As part of this transition we employed the wonderful Mandie Kai as programs and business manager for 12 exciting months. Within this brief period Mandie:

- overhauled our HR systems;
- established our employment legal framework;
- stimulated whole of organisation discussions about who and what Sprung!! is;
- attracted our first major sponsorship and major donor;
- sold nearly \$20,000 worth of raffle tickets in the French Cafe marketing campaign;
- breathed vitality into our volunteer network; and
- established a model for strong, firm human leadership and left the organisation with a \$50,000 EOFY profit!

While we were sorry to lose her to a demanding project with the Southern Cross University, the structures she helped established can now be further developed as we invest in the operational requirements of a sustainable arts organisation without losing the ensemble ethos that is at the core of what we perceive as valuable.

Going forward, we need to ensure balanced growth and the health of all program and organisational segments: our dancers, workers, guest artists, volunteers, communities, and Board, and we need to continue to aim for outcomes that reflect the balance of our core values: creativity, respect, integration, collaboration, and quality.

Artistic Director's Report

The highlight for YE 2019 for me has to be the gradual development and re-development of French Cafe with our collaborators- Liz Lea, Kate McDowell, and Brunswick Picture House, even though the actual performance was at the start of the current financial year- it was an overwhelming success, and again it showcased our dancers abilities to approach a variety of genres and to work with high production values. The fact that both Tara and Max got professional cabaret opportunities out of the process is evidence of the quality of their performances.

Other events in the year included:

- a jam-packed Summer Intensive program with 5 fantastic faciitators: Asher Bowen-Saunders, Che Pritchard, Serena Joy, Tess Eckert and Vivienne Frehner
- 2 weeks of clowning research with our actor-dancers matched 1:1 with tutors actors without disability, under the tutelage of the wonderful Giovanni Fusetti (supported by CASP and NRCF)
- 2 well-received performances at Tintenbar Up-Front
- a 10 week project with senior dancers at Feros Aged Care "positive living" program culminating in the inclusion of 11 senior dancers in our 2018 Gala
- Inclusion in the Lismore Quad program with a performance in the "Spin" Saturday night at the Chance Cycle
- Performances and workshops as invited guests at the BOLD Festival in Canberra
- Professional development for tutors and dancers attending performances and workshops at Dance Massive in Melbourne

- Original choreography for our usual front and centre Lismore Lantern Parade in June
- Ongoing running of the Senior Dance Program on Mondays and Fridays, Lismore Open doors on Thursdays with Tora and Katie, Clowning on 1st Saturdays and Open Doors 1st Sundays of the month (four x 10 week terms over the year)

Looking ahead, I am excited to continue to work with the Sprung dancers and their development. They continue to amaze me and I continue to recognise new ways of working physically and psychologically with them.

I look forward to mentoring Tora as Assistant Director of Dance Education in this subtle process, and of further developing exchange of process and techniques among our tutors. With the wonderful excitement of being included in the NORPA 2020 Season with *"O, How I Dreamt of Things Impossible"*, we intend to build on existing work and realise its potential in production in October 2020.

I also look forward to continuing to work with management and the Board to take the company forward.



Treasurer's Report

The figure below 'Income Streams YE 2017-19' demonstrates the impact that the decision to register for NDIS has had on cash flow for our organisation. Prior to October 2018, Sprung!! workshops ran at a loss, as the people with disability for whom they cater did not have significant disposable income, their disability funding being tied up in general with a single long-established provider. NDIS, with the motto, "choice, voice and control" has enabled people with disability to choose services from a variety of different providers, and to pay for these according to a transparent fee for service scale, allowing our many workshops to make a profit for the first time.

That this has been a success is shown not only in the cash flow, but also in the words of our auditor against the NSW Disability Services Standards, in which we received 100. He said, *"The approach that Sprung! uses embodies the promise of the National Disability Insurance Scheme - greater independence, community involvement, employment and improved wellbeing.*

Because of a genuine but limited increase in the number of participants in each program, and the number of workshops run, this figure will continue to increase over the next few years. However, we recognise that our unique "Way of Working" as evidenced in our values, and the quality of the training offered to our senior dancers by Michael Hennessy and our other long term skilled tutors, over a long period, are not "franchiseable". Therefore the number of workshops will eventually plateau.

It is important to understand that Sprung!! has managed to punch high and develop such a strong performance ensemble, with very limited resources for most of our existence to date. We have just appointed our first marketing officer in August 2019, and prior marketing investment amounted to less than \$1k annually in Facebook advertising! The strength of our performances and the quality of our engagements however is clear in this report, and this will be reflected in increasing ticket sales and gig engagements in the next few years as marketing and operational investment helps our standing to be recognised nationally.

Looking at the leading disability arts organisations in Australia, including Restless Dance Theatre, Back to Back Theatre, and Crossroad Arts, one also notices a dependence on grant income ranging from 65% to 85% of their total annual income. Sprung!! has not suffered from an excess of grants in recent times, and the need to earn income in real terms through workshop provision, and to increase the diversity of our income streams, will be to our advantage when the grants do begin to reward our financial stability, performance standards, and longevity in the business.

Our goals financially in the next two years will be to work in a united manner to understand, increase, and strengthen our audience, sponsor, and donor base, as well as to ensure organisational security through the mentorships of our two key longstanding personnel, Artistic Director Michael Hennessy and President Robyn Brady.

I would like to close by welcoming our incoming Treasurer, Mr Rowan Keast, a highly experienced Financial Advisor with Via Financial Group Byron Bay office.
