As a founding member, Macushla has asked us to create options for her which allow her to explore her creativity; ie. with individual ceramics tuition, at the Stonecutters' Studio in the stimulating melting pot environment of practicing regional artists & plans a small solo exhibition in June.

Drama, massage, performance, dance, art, computer graphics circus skills and music - doors have opened for her to develop these new skills. Showcasing her talents, interests and abilities is certainly easier given the removal of financial disadvantage allowing her the chance to seek out courses and tutors.

This young woman who has a keenly developed sense of theatre stunned us all recently when she treated us to a 20th birthday performance of her mermaid piece. The performance will be recreated soon for LINC TV - community television. She has also been invited to perform locally.

If ever government departments needed proof of the immediate returns on the money invested in nurturing the talents of this group of artists it was captured in the spotlight of the Mermaid Cafe.

## Art & Disability Research Project

The Australia Council the Federal Government's arts funding and advisory body, has commissioned a study of the arts and disability.

Researchers Juliet London and Des Walsh will be examining a range of issues, including the employment of people with a disability in the arts, the role of people with a disability as performers or artists and people with a disability as audience members.

The key aims of the project are to:

• evaluate barriers to access to the arts for people with a disability as audience members, artist/performers and employees/arts workers

• examine the emergence of "disability arts" as a distinct area of arts activity

 analyse the implications for arts organisations of the 1992 Commonwealth Disability Discrimination Act

• examine the ways in which people with a disability are reflected in or represented through the arts

• investigate the need for arts funders to provide stringent guidelines on arts and disability

 develop a framework for policy on arts and disability
